NAMES OF PERSONS AUTHORIZED TO TAKE CHILD FROM FACILITY

Child will not be allowed to leave with any person other than the mother, father, or step-parent without written parental consent. Personal identification may be required from any person taking a child from the facility. Mother, father, and step-parents are assumed to be on the list unless otherwise stated. Students will have all names removed from this list annually and must be resubmitted annually.

In the event that the name of a current or future employee of Culver City Christian School and/or Culver Community Church(hereinafter collectively referred to as "CCCS") is included in the list of names set forth hereinbelow, the authorizing party signing this document understands, acknowledges and agrees that in taking custody of the child, such authorized person("employee") is acting in his/her individual capacity and as a duly authorized agent of parent and is in no way acting as an employee or agent on behalf of CCCS. Any arrangement whereby an employee of CCCS provides after-school care for any student, whether or not for pay, constitutes a relationship outside of the course, scope and duty of employee's job description with CCCS and, therefore, constitutes a private agreement or other arrangement between such employee and the parent.

Parent, on behalf of himself/herself and on behalf of the student, hereby forever releases CCCS, as well as CCCS's officers, directors, employees, administrators, other agents and assignees, from any and all loss, cost or damage arising in any manner whatsoever from CCCS's release of the student to any of the persons identified in the following list, and parent agrees to indemnify and hold CCCS harmless from all such loss, cost or damage arising therefrom. Parent expressly agrees that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of California and that, if any portion of the agreement is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. Parent states that he/she has carefully read this release and knows the contents thereof and signs this release as and of his/her own free will. Parent, individually, and for and on behalf of the student, agrees not to bring or prosecute, or allow to be brought or prosecuted, any claims or suits against CCCS for any damages sustained or claimed as a result of the release of student to any of the persons named in the following list.

In the event that subsequent written authorization is received from the parent, authorized additional persons to take custody of child(ren), the names of which authorized persons have not been set forth in the following list, such authorization shall be deemed given by parent subject to all terms and conditions set forth above, including specifically the release of CCCS from any and all loss, cost, damage or liability.
